The repair ESTIMATES are as follows:

1. **Basic Repair: \$30.00** --- Includes unclogging and minor adjustments, shipping back to USA customers and a 30 day warranty. Parts sold separately.
2. **Intermediate Repair: \$80.00** --- Includes repairs that require disassembly of the mill, replacing small parts, shipping back to USA customers and a 90 day warranty. Parts sold separately.
3. **Complete Overhaul: \$160.00** --- Includes a complete REPLACEMENT of the motor/milling head assembly (essentially you have a brand new mill) and shipping back to USA customers. Other parts sold separately

Please note these policies:

- The above repair estimates are just that, estimates. They are described for your general knowledge.
 - All repair quotes include return shipping to you, the customer. So the quote is the complete price.
 - WhisperMills left in the possession of Grote Molen, Inc . for more than 30 days after the first contact, will become the property of Grote Molen, Inc.
